The programmes/presentations also familiarizes the Independent Directors with their roles, rights and responsibilities.

When a new Independent Director comes on the Board of the Company, a meeting is arranged with the Managing Director, Chief Financial Officer to discuss the functioning of the Board and the nature of the operation of the Company's business activities.

New independent Directors are provided with copy of latest Annual Report, the Code of Conduct of the Company, Schedule of upcoming Board and committee meetings.

A detailed Appointment Letter incorporating the role, duties and responsibilities, performance evaluation process, Code of Conduct and obligations on disclosures, is issued for the acceptance of the Independent Directors.

OTHER INITIATIVES TO UPDATE THE DIRECTORS ON A CONTINUING BASIS

At various Board meetings during the year, presentations are made to the Board on safety, health and environment and sustainability issue, company policies, changes in the regulatory environment applicable to the corporate sector and to the industry in which it operates.

Quarterly presentations on operations made to the Board include information on business performance, operations, market share, financial parameters, working capital management, fund flows, senior management change, major litigation, compliances, regulatory scenario etc.

Quarterly results are sent to the Directors.
